**HOME-TO-SCHOOL, EXTRACURRICULAR
TRANSPORTATION/BUS FLEET MAINTENANCE**

ADDENDUM AND MODIFICATION TO BID #15-16/01

The existing INSTRUCTIONS TO BIDDERS and SPECIAL PROVISIONS, are hereby modified as set forth below. Additions are noted with double underline.

Paragraph 2 of Section 1 SCOPE of the INSTRUCTIONS TO BIDDERS is hereby modified as follows:

This solicitation requests bids from highly qualified pupil transportation companies to operate the District's student transportation program for the 2015-16 school year, and for up to four (4) additional years, upon mutual agreement of the Contractor and District at the end of each year. This is a performance directed contract which shall require the Contractor to use its knowledge and expertise to provide safe and timely home-to-school and extracurricular transportation in a cost effective manner. The Contract details the District's requirements and performance parameters. The Contractor shall be required to operate a fleet of District busses, provide drivers for all busses, and to maintain all busses to satisfy the terms and conditions of the contract. The Contractor shall be expected to operate independently without supervision from the District. However, the District reserves the right to monitor Contractor performance to ensure Contract compliance.

Section 2 CONTRACT PERIOD of the INSTRUCTIONS TO BIDDERS is hereby modified as follows:

The District intends to award a contract for these services through the 2015-16 school year to the most qualified responsive, responsible bidder selected after evaluation of all bids. At the discretion of the Contractor and District, the contract will be renewable in one year term increments for up to four (4) additional years. The terms and conditions of this Contract and the requirements for transportation and maintenance are contained in the contract Specifications, Special Provisions and Contract Documents made a part here in.

Section 1 CONTRACT PERIOD of the SPECIAL PROVISIONS is hereby modified as follows:

The District anticipates award of this contract to be ratified at the Board of Education meeting on August 13, 2015. The contract shall be effective on August 12, 2015 with an initial term of approximately ten (10) months, expiring on June 30, 2015. The contract will provide for the optional renewal of the agreement at the end of each term. Both the District and Contractor will have absolute discretion to assent to the renewal. The length of each additional term shall correspond to the length of the initial term (one school year), except for any adjustments that may be necessary to

accommodate changes in the scheduling of the school year. In no event shall the agreement be renewed for more than four (4) additional terms. If the parties elect to renew the contract for an additional term, the total amount charged by the Contractor may be adjusted based on the Consumer Price Index for All Urban Consumers (CPI-U), as published by the United States Department of Labor, Bureau of Labor Statistics.

The Contractor shall cooperate with the District in phasing out operations at the end of the contract period. The District and the Contractor shall jointly develop a phase-out plan at least sixty (60) days prior to the end of the contract. The District shall provide direction for the close out.
